研究成果の概要(和文):本研究では、世界経済危機が南アジアとヨーロッパ、中南米における宗教的マイノリティの政治的アイデンティティと人間の安全保障に与えた影響を批判的に分析した。尚、本研究成果は著書Religion、Identity and Human Security (Routledge: 2014)として出版された。この中で、本研究の理論的枠組を提示している。実地調査は、主としてヨーロッパや南アジアの宗教的マイノリティのコミュニティにて実施した。

研究成果の概要(英文): This research project critically examined the impact of the financial crisis on human security and political identity in Europe, Latin America and South Asia. It resulted in the publication of the book: Religion, Identity and Human Security (Routledge: 2014). The book set out the theoretical framework for the project. Field research was mainly carried out on minority religious communities in Europe and South Asia.

1.研究開始当初の背景

Preliminary research on migration and human security had been conducted in Japan, North America, and Europe as a recipient of 平成 19-20 年度科学研究費補助金 (若手 研究 B) and in South Asia as a recipient of 平成 22-23 年度科学研究費補助金 (若手研究 B) which focused on Human Security in Southern Asia after the Global Financial Crisis and Implications for International Relations「世界経済危機後の南アジアの人 間の安全保障と国際関係の意義」. Furthermore, research has been carried out on the construction of religious, ethnic and cultural identities in South Asia and its Diaspora and was subsequently published as a book entitled Sikh Nationalism and Identity in a Global Age (Routledge 2007hbk, 2010 pbk).

2.研究の目的

The main aim of the project is to examine the relationship between neoliberalism, subjectivity and human insecurity after the financial crisis. Specifically, the project will assess the influence of the global financial crisis on collective political identities and human security through a comparative analysis of political movements in Europe, South Asia and Latin America. Due to limitations of funding and time, focus was concentrated upon the impact of the financial crisis upon ethno-religious minorities in Europe and South Asia. It was hoped that the research would contribute to the further institutionalization of a "critical human security paradigm " (Shani, Sato and Pasha 2007; Newman 2010; Shani 2010) in International Relations.

3.研究の方法

Research was conducted primarily in Europe and South Asia, with additional fieldwork on Latin America. The main objective of the research was to clarify the relationship between the financial crisis, human in/security and new forms of political action.

More specifically, it:

 a) Analyzed the influence of the global financial crisis on political identity in Europe and South Asia with special reference to minority ethnic and religious identities (and in Latin

- America indigenous identities);
- b) Accounted for the similarities and differences between responses to the financial crisis among member states of the EU, the South Asian Association for Regional Cooperation (SAARC); and, to a limited extent, *Mercosur*
- c) Examined forms of both violent (Naxalite, Maoist, Anarchist) and non-violent (CGIL-led strikes, Occupy, Los Indignados) mass political action and collective resistance to the measures imposed by in response to the crisis;
- d) Considered what Japan can learn from the experience of European states in dealing with debt and migration;
- e) Theoretically examined the limitations of "Human Security" and the dangers of its replacement with "resilience."

The methodological approach, in brief, involved developing an overview of the main impact of the financial crisis on political identities and human security in the EU, South Asia and Latin America. This required first reviewing existing literature on neoliberalism, human security and resilience; and second, interviews with academics and representatives of international organizations, most notably the International Organization of Migration in Rome.

4. 研究成果

This research project critically examined the impact of the financial crisis on human security and political identity in Europe, Latin America and South Asia. It resulted in the publication of the book: Religion. Identity and Human Security (Routledge: 2014). The book set out the theoretical framework for the project. Field research was mainly carried out in Europe and South Asia with additional fieldwork in Latin America. For FY2016-17, I was based in the Centre of International Studies at the London School of Economics and Political Science (LSE) where I was a Visiting Senior Fellow. My research while based in Europe primarily focused on the human security of *migrant* communities from minority religious backgrounds.

Interviews were conducted with academics

and senior members of international organizations, most notably the Chief of Mission of the International Organization of Migration (IOM) based in Rome. Due to time constraints and financial limitations, I was unable to conduct interviews with leaders of political movements or attend the World Social Forum.
