研究成果の概要(和文)：日本、ドイツ、スペイン、スウェーデン、メキシコ、ニュージーランド、中国、台湾におけるスノーデンの暴露に対する反応についての多国間比較研究。各国の類似と差異を明らかにすることにより、政府による検閲とプライバシー保護の概念に対する市民の捉え方について、有意義で興味深い示唆を示すものである。社会政策の問題を分析するために、映画研究の分析法は新しい方法で適用されてきた。この革新的な分析方法により、[スーパーヒーロー映画を通し]市民が技術的および法的な権力、統制、合理性、倫理などの諸概念を理解する過程を明らかにする。

研究成果の学術的意義や社会的意義

Use of film studies approaches to understand the impact of popular culture on understanding of policy issues.

An understanding of attitudes contributing to the public policy debate around surveillance.

研究成果の概要(英文)：A cross-country study of attitudes to Snowden's revelations in Japan, Germany, Spain, Sweden, Mexico, New Zealand, People's Republic of China, and Taiwan. Showing some useful and interesting similarities and differences between attitudes to government surveillance and expectations of privacy across those countries. In order to analyse social policy issues, the methods of film studies have been applied in new ways. This innovative method of analysis reveals the process by which citizens understand concepts such as technical and legal power, control, rationality, ethics, etc. via superhero movies

### 1 . 研究開始当初の背景

Ordinary people are now faced with significant invasions of their privacy and violations of their information security from multiple directions. While many of these problems require broad social solutions, there are areas of law, technology design and user practice that could improve the outcomes for many people.

### 2 . 研究の目的

To identify the pressures on ordinary people with regards to invasions of their privacy and violations of their security. To suggest further areas for research on developing technologies, novel legal approaches, or user habits which would significantly improve security without over-burdening users or those legitimately providing services to the benefit of users (without exploitation of those users).

### 3 . 研究の方法

A combination of conceptual work on identifying the problems of privacy and security for ordinary people, surveys on the habits and attitudes of those people, and suggested solutions to the problems. A novel approach using humanities (primarily film studies) to investigate ordinary people's understanding of security policy issues is being developed as part of the project.

### 4 . 研究成果

Finalise the statistical, historical and social analysis of an international survey of attitudes to Snowden's revelations about US and UK (and other countries') government mass spying on the electronic communications of ordinary citizens.

Explore superhero movies and their presentation of societal security threats as a method of understanding ordinary people's perceptions of security policy.
