研究成果の概要(和文):このプロジェクトはどのように現代の東アジア諸国の外交政策が19世紀以前の地域規準によって形作られてきたのかということを検証することによって、今日知られている「国際関係」が違った形で実践されてきただろうということを示すものである。また、本研究はそれぞれの問題がないわけではないが、西洋に支配されている国際システムに対する新しい道が存在するということを明らかにするものでもある。3年 間をかけて行われたこのプロジェクトの中で国際的に評価される出版社から4章分の本と2つの書評、1つの国際ジャーナル論文を出版してきた。

研究成果の学術的意義や社会的意義 一般的に、現代の「国際関係」はウェストファリア条約やヨーロッパ諸国が作り出した「国際」という概念の基 に作られていると信じられている。国際関係学という学問領域はそのような世界の残りを犠牲にし、西洋の利益 を反映させる世界観によって支配されてきた。この研究のよりと平り出行している。 1000円 10 描くための学術的研究に貢献する。この研究結果は日本の大衆に対してグローバル政治の一利害関係者として、 民主化を求めていかなければならないということに気づかせることができる。

研究成果の概要(英文):This project shows how "international relations" as we know it today could have been practiced differently by examining how contemporary East Asian state behavior might have been shaped by pre-19 century regional norms. It finds that alternatives to the Western dominated international system are available, although they are not without their problems. This three-year project has produced four book chapters, two book reviews, and one journal article, all by internationally renowned publishers.

1.研究開始当初の背景

The study of International Relations (IR) has been dominated by the Westphalian state paradigm ever since its birth as a discipline. In the past decade, an increasing number of IR scholars have begun to reflect on not only this analytical obsession with sovereign states but also the subsequent practice of knowledge production in IR that privileges Western experiences and worldview (as if they were readily applicable for understanding regional dynamics in other parts of the world). These reflections point to such important questions as: Why has IR developed in the way it has, e.g. dominated by Western theory at the expense of other geocultural sites' voices and concerns? What are the implications of the rise of Asia, China in particular, for IR as a discipline? What are the distinctive features in Asia's international relations for IR theorizing, if any?

2.研究の目的

Does the emerging "post-Western" turn in IR merely indicate a wishful thinking of some idealistic scholars who are too detached from the state-centric policy world? Can non-Westphalian norms and institutions ever influence foreign policy behavior in a supposedly Westphalian international system? If so, how? This research examines the conditions under which Confucian norms associated with the historical tribute system could become efficacious in shaping state behavior in contemporary East Asia. Western norm diffusion to the "non-West," this project suggests, entails non-linear processes of negotiations that involve local actors' agency informed by pre-existing norms.

3.研究の方法

To explore the conditions under which non-Westphalian norms could become efficacious in shaping state behavior in a region that has been socialized into the Westphalian society of states over a century, this three-stage research project will employ the technique of discourse analysis to investigate how core Confucian norms associated with the pre-20th century Sino-centric tribute system could inform relevant actors' strategic behavior in three representative case studies: (1) The ROK's belated recognition of the PRC and derecognition of the ROC, which resembles Korea's past difficulty in facing the epicenter's "regime change" in the 17th century. (2) The improvement of PRC-Taiwan relations since 2008 following Taipei's acceptance of its secondary status, which resembles China's hierarchical relations with its tributaries. (3) Taiwan's extensive relations with the U.S. and the PRC, which resembles the Japan-China-Ryukyu triangle.

4. 研究成果

Overall the course of research, the Principal Investigator realized that his (conventional) constructivist research design and case selection is flawed (anachronistic and still Eurocentric). The project took a postcolonial turn and produced four book chapters, two book reviews and a journal article was accepted in February 2019, all by internationally renowned publishers.
